Vice Chair McKenna made a motion that each Commissioner's voice may be adequately heard by each other Commissioner of the FCRHA.

Commissioner McAloon seconded the motion. The motion passed unanimously.

MOTION

Vice Chair McKenna made a motion that the State of Emergency caused by the COVID-19 pandemic makes it unsafe for the FCRHA and the public to physically attend this meeting in person, and the usual procedures cannot be implemented safely or practically. Commissioner Feng seconded the motion. The motion passed unanimously.

Vice Chair McKenna introduced the new FCRHA Commissioners, Commissioners Maribojoc, Robinson, and Alexander.

ELECTION OF OFFICERS

Vice Chair McKenna passed the virtual gavel to Commissioner Kelly.

Nominations were opened for Chairman of the FCRHA. A nomination was made by Commissioner Kennedy to nominate Commissioner McKenna as Chair of the FCRHA. Commissioner Bell seconded the nomination. With no other nominations presented, a vote was taken and passed with Commissioner McKenna abstaining to elect Commissioner McKenna as Chair of the FCRHA.

Commissioner Kelly passed the virtual gavel to Chair McKenna, who then opened the floor to nominations for Vice Chair. A nomination was made by Commissioner Feng to nominate Commissioner Kennedy as Vice Chair of the FCRHA. Commissioner McAloon and Commissioner Solomon seconded the nomination. Commissioner Kennedy declined the nomination. A nomination was made by Chair McKenna to nominate Commissioner Kelly as Vice Chair of the FCRHA. Commissioner Bell and Commissioner Dunn seconded the nomination. With no other nominations presented, a vote was taken and passed unanimously to elect Commissioner Kelly as Vice Chair of the FCRHA.

WHEREAS, during his tenure, the FCRHA continued to be recognized as one of the finest housing authorities in the United States, consistently receiving national awards for excellence from the National Association of Counties and the National Association of Housing and Redevelopment Officials; and

WHEREAS, the FCRHA seeks to publicly recognize the commitment and dedication of Robert Schwaninger, and thank him for his thoughtful leadership and guidance; and

WHEREAS, Robert Schwaninger has completed his distinguished service to the FCRHA;

NOW, THEREFORE, BE IT RESOLVED, that the FCRHA expresses its deepest and most sincere appreciation to Robert Schwaninger for his many years of outstanding service to the citizens of Fairfax County; and

RESOLUTION NUMBER 51-20

Award of \$2,899,197 in Federal Community Development Block Grant Program Funds
and HOME Investment Partnerships Program Funds (Including HOME Community
Housing Development Organization Program Funds) to Four Fairfax County Nonprofit
Housing Organizations

BE IT RESOLVED that the Fairfax County Redevelopment and Housing Authority (FCRHA) authorizes the Chairman, Vice Chairman, or any Assistant Secretary of the FCRHA to negotiate, execute and deliver contracts, loans and any other necessary or appropriate documents or agreements, in accordance with the applicable federal regulations for the use of Community Development Block Grant and HOME Investment Partnerships Program Funds, with the following nonprofit organizations, as more fully described in the Item presented to the FCRHA at its December 17, 2020, meeting:

(1) \$445,485 to Sunrise Community of Virginia, Inc. to acquire and renovate a single-family home to provide community living for five individuals with household incomes at or below 30 percent of the Area Median Income (AMI) with medically complex intellectual and physical

development disabilities.

- (2) \$457,000 to Marian Homes, Inc. to acquire and renovate a single-family home to provide community living for five individuals with household incomes at or below 30 percent of AMI with intellectual disabilities.
- (3) \$468,000 to Good Shepherd Housing and Family Services to acquire and renovate two condo units for families who have experienced homelessness with incomes at or below 60 percent of AMI.
- (4) Up to \$1,528,712 to Pathway Homes, Inc. to acquire and rehabilitate units of affordable rental housing to provide affordable housing and supportive services to 9 or 10 individuals who have experienced homelessness or are precariously housed and have special needs related to mental illness, co-occurring substance abuse disorders and intellectual disorders with incomes at or below 30 percent of AMI.

Commissioner Bell moved to adopt Resolution Number 51-20, which Commissioner Kelly seconded. The motion passed unanimously.

Partnership from SAH 99 Fund I, LLC (Lee District)

BE IT RESOLVED that the Fairfax County Redevelopment and Housing Authority (FCRHA) authorizes the purchase of the limited partnership interests in Morris Glen Limited Partnership, as described in the Closed Session Item on December 17, 2020; and

BE IT FURTHER RESOLVED that the FCRHA authorizes the execution, in its capacities as both managing general partner and incoming limited partner, of the proposed Assignment and Assumption Agreement and Second Amendment to Amended and Restated Agreement of Limited Partnership (Agreement), in substantially the form attached to the item presented to the FCRHA; and

BE IT FURTHER RESOLVED that the FCRHA further consents to the proposed transaction in its capacity as a lender to Morris Glen Limited Partnership; and

BE IT FURTHER RESOLVED that the FCRHA authorizes any Assistant Secretary to execute and deliver the Agreement and further authorizes staff to take such other steps as may be reasonably necessary to effectuate the purposes of the Agreement.
