BE IT FURTHER RESOLVED that the FCRHA authorizes its Chairman, Vice

Chairman or any Assistant Secretary to execute all documents and agreements and to take any other steps necessary or appropriate in connection with the purchase of the units as described in the Action Item presented to the FCRHA on September 19, 2019.
