for Affordable Housing (APAH) for the Development of the Oakwood Senior Housing Property (Lee District)

FCRHA Chairman Schwaninger handed the gavel to Vice Chair Melissa Jonas.

MOTION

Chairman Schwaninger made a motion that the Fairfax County Redevelopment and Housing Authority defer the Public Hearing on the Proposed Comprehensive Agreement with Arlington Partnership for Affordable Housing (APAH) for the Development of the Oakwood Senior Housing Property (Lee District) to a date certain of January 30, 2020. Commissioner Craig seconded the motion. The motion passed unanimously.

Public Hearing on the Proposed Comprehensive Agreement with One University Development Partners, LLC for the Redevelopment of the One University Properties (Braddock District)

ACTION ITEM

RESOLUTION NUMBER 51-19

Award of \$2,366,875 in Federal Community Development Block Grant Program Funds and HOME Investment Partnerships Program Funds (including HOME Community Housing Development Organization Program Funds) to Three Fairfax County Nonprofit Housing Organizations

BE IT RESOLVED that the Fairfax County Redevelopment and Housing Authority (FCRHA) authorizes the Chairman, Vice Chairman, or any Assistant Secretary of the FCRHA to negotiate, execute and deliver contracts, loans and any other necessary or appropriate documents or agreements, in accordance with the applicable federal regulations for the use of Community Development Block Grant and HOME Investment Partnerships Program Funds, with the following nonprofit organizations, as more fully described in the item presented to the FCRHA at its December 12, 2019, meeting:

- (1) \$277,400 to Good Shepherd Housing and Family Services to acquire and renovate two (2) 2-bedroom condominium units within Alexandria. Residents would be provided rental housing as well as services to support their progress toward self-sufficiency. These units will serve two families who have experienced homelessness with incomes at or below 50 percent of Area Median Income (AMI), subject to underwriting by the Department of Housing and Community Development (HCD) Loan Underwriting Committee; and
- (2) \$470,000 to Marian Homes, Inc. to acquire and renovate a single-family home to provide community living for five individuals with household incomes at or below 30 percent of AMI with intellectual disabilities. Community Development Block Grant funds will be used exclusively for the acquisition of this unit, subject to underwriting by the HCD Loan Underwriting Committee, and

> (3) \$1,619,475 to Pathway Homes, Inc. to acquire ten (10) 1-bedroom units of affordable rental housing to provide affordable housing and supportive services to individuals who have experienced homelessness or are precariously housed and have special needs related to mental illness, co-occurring substance abuse disorders and intellectual disorders with incomes at or below 30 percent of AMI, subject to underwriting by the HCD Loan Underwriting Committee.

Commissioner Bell moved to adopt Resolution Number 51-19, which Commissioner Feng seconded. The motion passed unanimously.

RESOLUTION NUMBER 52-19

Authorization to Modify the Terms of the Contracts for Deferred Loans to Good
Shepherd Housing and Family Services, Inc. (\$590,900) for Use of Federal Community
Development Block Grant Funds

BE IT RESOLVED that the Fairfax County Redevelopment and Housing Authority (FCRHA) authorizes the modification of its FY2020 CCFP CDBG award to Good Shepherd Housing and Family Services, Inc. (Good Shepherd), originally made on June 13, 2019, to require the acquisition of four (4) units instead of six (6) units with the FY 2020 funds; and

BE IT FURTHER RESOLVED that the FCRHA authorizes the Chairman, Vice Chairman, Secretary, or any Assistant Secretary of the FCRHA to negotiate, execute and deliver such documents as reasonably necessary to so modify the existing agreements with Good Shepherd.

After a brief presentation, Commissioner Bell moved to adopt Resolution Number 52-19, which Commissioner Solomon seconded. The motion passed unanimously.

BE IT RESOLVED that the Fairfax County Redevelopment and Housing Authority (FCRHA) approves the revision of Chapter 18, Rental Assistance Demonstration Vouchers, of its Housing Choice Voucher Program Administrative Plan, as presented to the FCRHA at its meeting on December 12, 2019.
