MINUTES OF THE MEETING OF THE FAIRFAX COUNTY REDEVELOPMENT AND HOUSING AUTHORITY

July 19, 2018, Annual Meeting

On July 19, 2018, the Commissioners of the Fairfax County Redevelopment and Housing Authority (FCRHA) met in the FCRHA Board Room, One University Plaza, 4500 University Drive, Fairfax, Virginia.

CALL TO ORDER

FCRHA Chair Robert Schwaninger called the Meeting of the FCRHA to order at 7:00 p.m. Attendance for all, or part of the meeting, was as follows:

ELECTION OF OFFICERS

FCRHA Chair Robert Schwaninger handed the gavel to Vice Chair Jonas to conduct the election of the Chair. Nominations were opened for Chairman of the FCRHA. A

nomination was made by Commissioner Kennedy to nominate Commissioner Schwaninger as Chairman of the FCRHA. With no other nominations presented, Vice Chair Jonas moved to close the nominations with Commissioner Solomon seconding the motion. A vote was taken and passed unanimously to elect Commissioner Schwaninger as Chair of the FCRHA.

FCRHA Vice Chair Melissa Jonas handed the gavel to Chairman Schwaninger, who then opened the floor to nominations for Vice Chair. A nomination was made by Commissioner Solomon to nominate Commissioner Jonas as Vice Chair of the FCRHA. With no other nominations presented, Chairman Schwaninger moved to close the nominations with Commissioner McAloon seconding the motion. A vote was taken and passed unanimously to elect Commissioner Jonas as Vice Chair of the FCRHA.

CITIZEN TIME

The FCRHA Chair opened Citizen Time at 7:02 p.m. Ms. Stephanie Clarke spoke to the Commissioners regarding the First-Time Homebuyers program and an action that was taken during the June 14, 2018 FCHRA meeting authorizing staff to purchase the Moderate Income Direct Sales (MIDS) Property owned by her mother.

Mr. Jim Edmondson spoke to the Commissioners regarding the terms of the use of subordinated debt provided by the FCRHA in Low Income Housing Tax Credit transactions. With no one else in the audience wishing to speak, the Chair closed Citizen Time at 7:14 p.m.

APPROVAL OF MINUTES June 14, 2018

Commissioner Kennedy moved to approve the Minutes of the June 14, 2018, FCRHA Meeting, which Commissioner Bell seconded. The motion passed unanimously with Commissioners Jonas and Solomon abstaining.

Authorization to Enter into Contracts and Make Deferred Loans Using Federal Community Development Block Grant Funds to the Following Non-Profit Organizations: (1) Pathway Homes, Inc. (\$450,000); and (2) Good Shepherd Housing and Family Services, Inc. (\$254,500)

BE IT RESOLVED that the Fairfax County Redevelopment and Housing Authority (FCRHA) authorizes the Chairman, Vice Chairman, Secretary, or any Assistant Secretary of the FCRHA to negotiate, execute and deliver contracts, loans and any other necessary or appropriate documents or agreements, in accordance with the applicable federal regulations for the use of Community Development Block Grant Funds, consistent with the approvals of the Fairfax County Board of Supervisors, as more fully described in the Item presented to the FCRHA at its July 19, 2018 meeting, between the FCRHA and:

(1) Pathway Homes, Inc. in the amount of \$450,000 for the acquisition and renovation of one (1) or more housing units, subject to underwriting by the Fairfax County Department of Housing and Community Development's (HCD) Loan Underwriting Committee, which unit(s) will be used to provide affordable rental housing for households at or below 30 percent of the Area Median Income (AMI), for persons with mental illnesses and/or substance use disorders, or mild intellectual disabilities who are homeless, unstably housed or ready to step down from more intensive levels of care; and

(2) Good Shepherd Housing and Family Services, Inc. in the amount of \$254,500 for the acquisition and renovation of two (2) or more housing units, subject to underwriting by the Loan Underwriting Committee, which will be used to provide affordable rental housing for households at or below 50 percent of AMI.

Commissioner Greenlief moved to adopt Resolution Number 25-18, which Commissioner Kennedy seconded. The motion passed unanimously.
