BE IT RESOLVED, THAT the Fairfax County Redevelopment and Housing Authority (FCRHA) authorizes the execution of the proposed Development Agreement by and among Arlington Partnership for Affordable Housing, Inc. (APAH), the Board of Supervisors of Fairfax County (Board), and the FCRHA to facilitate the development of the Tysons Community Center integrated within the Dominion Square West project, as outlined in the Action Item presented to the Board at its meeting on June 27, 2023.
