APPROVAL OF MINUTES January 20, 2022

RESOLUTION NUMBER 03-22

Authorization to Exercise the Option to Purchase One Affordable Dwelling Unit at Commonwealth Place at Westfields – Phase IV (Sully District)

WHEREAS, Section 5101.2 (formerly Section 2-802) of the Fairfax County Zoning Ordinance requires developers to provide Affordable Dwelling Units (ADUs) in new residential developments affordable to households whose incomes are 70 percent or less of the Area Median Income (AMI) and Section 5101.8(A)(2) (formerly Section 2-810(2)) of the Fairfax County Zoning Ordinance provides the option for the Fairfax County Redevelopment and Housing Authority (FCRHA) to purchase up to one-third of the ADUs.

WHEREAS, Phase IV of the Commonwealth Place at Westfields development includes four ADUs, with the FCRHA having the right to purchase one ADU.

BE IT RESOLVED that the FCRHA hereby authorizes the purchase of one ADU at the Commonwealth Place at Westfields development; and

BE IT FURTHER RESOLVED that the FCRHA hereby authorizes a total purchase price not to exceed \$210,027 from Fund 400-C40300, Housing Trust Fund, Project HF-000093, ADU Acquisitions, and Rehab, for the acquisition of the one ADU at the Commonwealth Place at Westfields development; and

BE IT FURTHER RESOLVED that the FCRHA authorizes its Chair, Vice Chair, or any Assistant Secretary to execute all documents and agreements and to take any other steps necessary or appropriate in connection with the purchase of the unit as described in the Action Item presented to the FCRHA on February 24, 2022.

Vice Chair Stanton moved to adopt Resolution Number 03-22, which Commissioner Feng seconded. The motion passed unanimously.

Authorization to Write-Off Certain Tenant Accounts Receivable

RESOLUTION NUMBER 05-22

Adoption of the Fairfax County Redevelopment and Housing Authority (FCRHA) Strategic Plan for Fiscal Year (FY) 2023

WHEREAS, the Fairfax County Redevelopment and Housing Authority (FCRHA) adopted a Five-Year Strategic Plan for the period from July 1, 2010, through June 30, 2015; and

WHEREAS, the FCRHA extended its Five-Year Strategic Plan through Fiscal Year (FY) 2018 (June 30, 2018); and

WHEREAS, the FCRHA annually adopts a Strategic Plan – Action Plan outlining how the FCRHA and the Department of Housing and Community Development will meet the goals of the Five-Year Strategic Plan; and

WHEREAS, for FY 2019, the FCRHA adopted the FCRHA Strategic Plan for FY 2019, which incorporated the elements of the extended FCRHA Five-Year Strategic Plan into one Strategic Plan and Action Plan document; and

WHEREAS, the FCRHA desires to continue implementing an FCRHA Strategic Plan that contains a detailed action plan of projects to be undertaken during the fiscal year;

NOW THEREFORE BE IT RESOLVED that the FCRHA does hereby adopt the FCRHA Strategic Plan for FY 2023, as presented to the FCRHA at its meeting on February 24, 2022.
