ELECTION OF OFFICERS

FCRHA Chairman McKenna handed the gavel to Vice Chair Stanton to conduct the election of the Chair. Nominations were opened for Chair of the FCRHA. A nomination was made by Chairman McKenna to nominate Vice Chair Stanton as Chairman of the FCRHA. With no other nominations presented, Vice Chair Stanton moved to close the nominations. A vote was taken and passed unanimously to elect Vice Chair Stanton as Chairman of the FCRHA.

APPROVAL OF MINUTES

RESOLUTION NUMBER 17-23

Authorization to Terminate Lease Agreement at Sojourn House, Group Home, (Springfield District), with Fairfax County-Falls Church Community Services Board (CSB) and Enter into Direct Landlord Status and Lease Agreement with the Fairfax County Redevelopment and Housing Authority (FCRHA) and Managed by the Fairfax County Department of Housing and Community Development (HCD)

BE IT RESOLVED that the Fairfax County Redevelopment and Housing Authority (FCRHA) authorizes the termination of the lease agreement for Sojourn House Group Home (Springfield District) between Fairfax County-Falls Church Community Services Board (CSB) and the FCRHA and relinquishment by CSB to the Department of Housing and Community Development (HCD) of all management, maintenance and financial oversight to DHCD along with CSB submitting \$908,268.78 to DHCD for the future maintenance and capital needs along with the remaining mortgage balance as outlined in the Administrative Action Item presented to the FCRHA at its meeting on July 20, 2023:

AND FURTHER authorizes entry of a direct lease agreement for Sojourn House Group Home (Springfield District) with the current subtenant.

Commissioner Feng moved to adopt Resolution Number 17-23, which Commissioner Kennedy seconded. The motion passed unanimously.

RESOLUTION NUMBER 18-23

Adoption of Fairfax County Redevelopment and Housing Authority Position Statements for Consideration in the 2024 Fairfax County Legislative Program

BE IT RESOLVED, that the Fairfax County Redevelopment and Housing Authority (FCRHA) adopts two legislative positions as outlined in the accompanying item for consideration by the Fairfax County Board of Supervisors for the 2024 Legislative Program at its July 20, 2023, meeting. Specifically, the FCRHA approves the submission of the following position statements to the Fairfax County Board of Supervisors: (1) support for the federal Affordable Housing Credit Improvement Act and (2) support to lift the Virginia Department of Housing and Community Development's annual bond cap.

After discussion, Commissioner Kennedy moved to adopt Resolution Number 18-23, amending the resolution to include support for other similar federal legislation currently before the U.S. Congress that enhances tax credits or other financing tools for affordable housing development, which Chair Stanton seconded. The motion passed unanimously.

RESOLUTION NUMBER 19-23

Authorization to Assign the FCRHA's Right of First Refusal and to Permit Assumption of the Existing FCRHA Loan to Facilitate the Acquisition and Renovation of Coralain Gardens Apartments, 7435 Arlington Boulevard, Falls Church, VA 22042 (Mason District)

WHEREAS, staff has reviewed proposals from various housing providers to assume the FCRHA's Right of First Refusal to Coralain Gardens Apartments and determined Enterprise Community Development's proposal to be the most clearly in favor of the FCRHA's interests;

WHEREAS, Enterprise Community Development (the Purchaser) requested to assume an existing FCRHA loan with a balance of \$4,490,290.82 as of March 2023, as a source of financing for the acquisition of Coralain Gardens Apartments; and

WHEREAS, the Fairfax County Redevelopment and Housing Authority (FCRHA) agrees with the assistance of the Purchaser to acquire the Coralain Gardens Apartments in order to maintain affordable multifamily rental housing in Fairfax County by enabling the assumption of the loan.

NOW, THEREFORE, BE IT RESOLVED that the FCRHA hereby authorizes:

- 1) The assignment of its Right of First Refusal on Coralain Gardens Apartments to Enterprise Community Development.
- 2) The assumption of the existing FCRHA loan on the Coralain Gardens Apartments, by Enterprise Community Development to facilitate the acquisition and renovation of the property.
- 3) HCD staff to proceed with an alternative proposal if necessary, if the terms of the alternative conform to those requirements as described in the Action Item presented to the FCRHA on July 25, 2023.

BE IT FURTHER RESOLVED that the FCRHA authorizes Thomas E. Fleetwood, Assistant Secretary, or any Assistant Secretary to negotiate all transaction terms on behalf of the FCRHA and authorizes its Chairman, Vice Chairman or any Assistant Secretary to execute all documents, agreements, and instruments reasonably necessary or appropriate in connection with the assignment of the ROFR and/or the assumption of the loan for the acquisition of Coralain Gardens Apartments.

Commissioner Kennedy moved to adopt Resolution Number 19-23, which Commissioner Feng seconded. The motion passed unanimously.

ACTION ITEM

Authorization, Subject to the Approval of the Fairfax County Board of Supervisors, to Fund up to \$8,000,000 of the Acquisition Costs of the Telestar Court Redevelopment (Providence District)

WHEREAS, Merrifield Housing, LLC (Tenant)— a joint venture of Conifer Realty, LLC and Joseph Browne Development Associates — submitted a request for financial assistance for the redevelopment of the 80-unit Telestar Court project located at 2990 Telestar Court, Falls Church, Virginia (Project); and

WHEREAS, the Fairfax County Redevelopment and Housing Authority (FCRHA) wishes to assist Tenant in the redevelopment of the Project to produce affordable multifamily rental housing in Fairfax County by providing funding in the amount of up to \$8,000,000 toward the acquisition costs of the Project site.

NOW, THEREFORE, BE IT RESOLVED that the FCRHA, subject to approval by the Fairfax County Board of Supervisors, hereby authorizes making an expenditure for the acquisition and redevelopment of the Project in the amount of up to \$8,000,000, as described in the Action Item presented to the FCRHA on July 20, 2023; and

BE IT FURTHER RESOLVED that the FCRHA authorizes Thomas E. Fleetwood, Assistant Secretary, or any other Assistant Secretary, to negotiate all terms on behalf of the FCRHA and authorizes its Chairman, Vice Chairman or any Assistant Secretary to execute all documents, agreements, and instruments reasonably necessary or appropriate in connection with expending up to \$8,000,000 for the Project.

Commissioner Kennedy moved to adopt Resolution Number 20-23, which Chair Stanton seconded. The motion passed unanimously.
